Regulations

- Although requests will be considered, the Review Committee retains complete discretion in assigning booth locations.
- The vendor must be present during all show hours – If a vendor breaks down before the show ends, they will not be invited back to Holly Days the following year.
- The vendor may decorate their space, but decorations must be appropriate to the season.
- Set-up for the show will be Friday, December 1st, 9am-5pm and Saturday, 7:00-8:30 a.m. Break-down will be immediately following the show (3:00-5:00pm)

Application Process

To be considered, vendor **applications must be turned in no later than August 31st**. Vendors will be notified no later than September 25th with an acceptance letter. No refunds will be issued for cancellations if you are accepted to the show. Acceptance to the Show **will not** be based solely on “first-come, first serve”. This includes space assignments. Space is limited and acceptance to the Show will be based on the images of the crafts/art submitted with the application. Craft/book signings/art demonstrations are a plus. Although specific space requests will be considered, spaces will be assigned by the Review Committee.

Submit the following:

- Application form completed and signed.
- Two images of crafts/artwork (JPG on CD or prints accepted) or website where items can be viewed.
- If demonstration of craft planned, please include description and any special requirements
- Include a self-addressed, stamped envelope (with adequate postage) if you would like your images returned.
